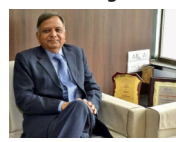

The government reopened educational institutions including schools, colleges and coaching centres earlier on January 4 after nine months. Classes with 50% attendance were held for students of standards 9-12 in schools and final year students in colleges. 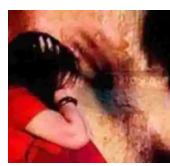
